

ORDINANCE TO AMEND THE CODE OF ORDINANCES, CITY OF MARSHALLTOWN, IOWA BY AMENDING CHAPTER 77, PARKING SCHEDULES, SCHEDULE X PUBLIC ACCESS PARKING

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARSHALLTOWN, IOWA:

Section 1. The Code of Ordinances, City of Marshalltown, Iowa is hereby amended by replacing the table listed in CHAPTER 77 PARKING SCHEDULES, SCHEDULE X PUBLIC ACCESS PARKING, Section (C)(2):

Street	Location
1st Avenue	From State Street to 280 feet south of Church Street, except as provided in division (C)(1) above
1st Street	From 180 feet south of Grant Street to Church Street
1st Street	From Church Street to a point 180 feet south
2nd Avenue	From the alley south of State Street to the alley south of Church Street
2nd Street	From Church Street to State Street
13th Street	Both sides, from Fremont Street to Summit Street
Center Street	From 120 feet south of Grant Street to Linn Street, except as provided in division (C)(1) above
Church Street	From 3rd Avenue to 2nd Street
Linn Street	South side, from S. Center Street to S. 3rd Avenue
Main Street	From 3rd Avenue to 3rd Street, and the south side of Main Street between 3rd Avenue and 5th Avenue, except as shown in division (C)(1) above and disabled parking as provided in Ch. 77, Schedule IX, of this code of ordinances
Main Street	South side between 3rd Avenue and 5th Avenue, except for 30-minute parking as provided in division (C)(1) above and disabled parking as provided in Ch. 77, Schedule IX, of this code of ordinances
State Street	From 3rd Avenue to 3rd Street Municipal parking lots as follows, except for specific government vehicle spaces: Lot T, 15 W. State Street

Section 2. That this ordinance shall be in full force and effect after its passage and publication as by law.
