

**ORDINANCE 15051**

**AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, CITY OF MARSHALLTOWN, IOWA, CHAPTER 73: RECREATIONAL VEHICLES TO PROHIBIT THE USE OF ALL TERRAIN VEHICLES AND OFF-ROAD UTILITY VEHICLES**

**WHEREAS**, the City Council of the City of Marshalltown, Iowa, has adopted Chapter 73, Recreational Vehicles to provide regulations for recreational equipment, bicycles, and snowmobiles; and

**WHEREAS**, the State of Iowa implemented a new law allowing the use of all-terrain vehicles and off-road utility vehicles on city streets as authorized by a city; and

**WHEREAS**, the City of Marshalltown desires an amendment to the Code of Ordinances to prohibit the use of all-terrain vehicles and off-road utility vehicles; and

**WHEREAS**, the City Council of the City of Marshalltown finds it is in the best interest of the City to amend Chapter 73: Recreational Vehicles of the City Code of Ordinances.

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARSHALLTOWN, IOWA:**

**Section 1.** The Code of Ordinances is hereby amended by adopting the following section:

**73.003 PROHIBITION ON ATVS/UTVS**

No person shall be allowed to operate an all-terrain vehicle or off-road utility vehicle on any primary highway, principal or minor arterial roadway, primary or secondary road, or city, collector, or local street within city limits or on any City-owned property, with the exception of the Iowa River OHV Park. The operation of all-terrain vehicles or off-road utility vehicles may be permitted during parades, special events, or other public purposes as specifically authorized by the City Council or its designee. This prohibition shall not apply to operation of an all-terrain vehicle or off-road utility vehicle by the City or City employees for public safety services or other City-service related uses.

**Section 2.** That this ordinance shall be in full force and effect after its passage and publication as by law.
