

**ORDINANCE 15052**

**AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, CITY OF MARSHALLTOWN, IOWA, CHAPTER 73: RECREATIONAL VEHICLES TO PROHIBIT THE USE OF GOLF CARS**

**WHEREAS**, the City Council of the City of Marshalltown, Iowa, has adopted Chapter 73, Recreational Vehicles to provide regulations for recreational equipment, bicycles, and snowmobiles; and

**WHEREAS**, regulations pertaining to golf carts, which have existed since the adoption of Ordinance 14137 in 1982, are found in Chapter 70.006 though considered a recreational vehicle; and

**WHEREAS**, the City of Marshalltown desires to keep rules and regulations of recreational vehicles like golf carts in a consistent location in the Code of Ordinances; and

**WHEREAS**, the City Council of the City of Marshalltown finds it is in the best interest of the City to amend Chapter 73: Recreational Vehicles of the City Code of Ordinances.

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARSHALLTOWN, IOWA:**

**Section 1.** The Code of Ordinances, City of Marshalltown, Iowa is hereby amended by adopting the following sections:

**Golf Cars**

**73.065 DEFINITIONS.**

For the purposes of this subchapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

***GOLF CAR.*** A three or four-wheeled recreational vehicle generally used for the transportation of persons in the sport of golf on a golf course.

**73.066 OPERATION IN CITY LIMITS.**

Golf cars are prohibited from operating on City streets. The operation of golf cars may be permitted during parades, special events or other public purposes as specifically authorized by the City Council or its designee. This prohibition shall not apply to operation of golf cars by the City or City employees for public safety services or other City-service related uses.

**Section 3.** City of Marshalltown Code of Ordinance section 70.006(B)1 through (B)2 are hereby repealed.

**Section 4.** That this ordinance shall be in full force and effect after its passage and publication as by law.
