

**RESOLUTION ACCEPTING BID AND AUTHORIZING THE PURCHASE OF TWO 2023 CHEVROLET TAHOE POLICE PACKAGE VEHICLES FROM KARL CHEVROLET FOR THE PRICE OF \$120,375.94 FOR USE IN THE POLICE DEPARTMENT AS EMERGENCY RESPONSE VEHICLES AND DECLARING CERTAIN PROPERTY SURPLUS PROPERTY AND AUTHORIZING SALE AND DISPOSAL THEREOF TO KARL CHEVROLET TWO 2017 FORD INTERCEPTOR POLICE PACKAGE VEHICLES FOR \$11,000.00**

**WHEREAS**, the City of Marshalltown (hereinafter referred to as the “City”), State of Iowa, is a political subdivision organized and existing under the law and the Constitution of the State of Iowa (the “State”); and

**WHEREAS**, the City desires to procure two, 2023 Chevrolet Tahoe police package vehicles to be utilized by the police department as emergency response vehicles and sought quotes for this purpose; and

**WHEREAS**, Karl Chevrolet of Cedar Rapids, Iowa submitted a bid for this police vehicle purchase for a total purchase price of \$120,375.94 and offered to credit the City \$11,000.00 in total trade value on two, 2017 Ford Interceptor police package vehicles that are being retired from the police department fleet. Less trade value on the two retired vehicles, the purchase price of the two, new 2023 Chevrolet Tahoe police package vehicles is \$109,375.94; and

**WHEREAS**, the City is the sole owner of two, 2017 Ford Interceptor police package vehicles which are to be declared surplus property and disposed of or sold to raise additional revenue and prevent the further decline in value thereof prior to sale; and

**WHEREAS**, the acceptance of this bid and disposal of surplus property is in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF MARSHALLTOWN, IOWA:**

**Section 1.** The City accepts the bid from Karl Chevrolet for the purchase of two, 2023 Chevrolet Tahoe police package vehicles to be used as a police response vehicle for \$120,375.94. Less trade value of the surplus property (\$11,000.00), the purchase price of the two, new 2023 Chevrolet Tahoe police package vehicles decreases to \$109,375.94.

**Section 2.** The property listed below is hereby declared as surplus property:

1. 2017 Ford Interceptor, VIN: 1FM5K8AR9HGD57655
2. 2017 Ford Interceptor, VIN: 1FM5K8AR2HGA37223

**Section 3.** The surplus property the subject of this resolution shall be sold or disposed of in accordance with applicable Federal, State and City guidelines.

**Section 4.** The Chief of Police of the City is hereby authorized to enter into agreements on behalf of the City to purchase said vehicles at the above referenced price and conditions.
