

ORDINANCE 15113

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, CITY OF MARSHALLTOWN, IOWA, BY REPEALING AND REPLACING CHAPTER 72 PARKING RULES, SECTIONS 72.102(B) AND 72.109

WHEREAS, the City Council of the City of Marshalltown, Iowa has adopted Chapter 72 Parking Rules; and

WHEREAS, the City Council finds the following amendment to be in the best interest of the City of Marshalltown.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARSHALLTOWN, IOWA:

Section 1. The Code of Ordinances of the City of Marshalltown is hereby amended by repealing Chapter 72: Parking Rules, Sections 72.102(B) and 72.109 and adopting the following in its place:

§ 72.102 OVERTIME AND ALTERNATE PARKING.

(B) The allowable configuration of on-street parking shall be as identified by pavement markings and/or signage and meet rules as shown in Section § 72.109. Parking signage shall pertain to all parking within that block, on the side of the street the sign is on, unless otherwise designated by additional signage.

§ 72.109 PARKING CONFIGURATION.

(A) Parallel. Except where no parking, 90-degree, angle, or center parking is allowed, parking of a vehicle, trailer, or recreational vehicle shall be parallel parked with the right-hand wheels of such vehicle, trailer, or recreational vehicle parallel with and within 18 inches of the right-hand curb. Where a one-way roadway is permitted by ordinance, the left-hand wheels may also be adjacent to and within 18 inches of the left-hand curb. End to end, parallel parking shall not be closer than four feet from another vehicle, trailer, or recreational vehicle.

(B) 90-Degree. Vehicles may either pull forward or back-in to 90-degree parking configuration stalls. No vehicle, trailer, or recreational vehicle shall be parked in a 90-degree parking configuration stall if the end of the vehicle extends into the travelled way(s) of the street.

(C) Angle (Pull-in). Where pavement markings indicate angle parking, they shall be forward pull-in angle parking, unless signage indicates back-in only angle parking. No vehicle, trailer, or recreational vehicle shall be parked in an angle parking configuration stall if the end of the vehicle extends into the travelled way(s) of the street.

(D) Angle (Back-in). Where pavement markings indicate angle parking and signage indicates back-in only angle parking, all vehicles shall back-in angle park. No vehicle, trailer, or recreational vehicle shall be parked in an angle parking configuration stall if the end of the vehicle extends into the travelled way(s) of the street.


Section 2. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. Severability Clause. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

Section 4. When Effective. This ordinance shall be in full force and effect after its final passage, approval, and publication as provided by law.


