ORDINANCE AMENDING ORDINANCE #14571 PROVIDING FOR THE SETTING OF THE RATE
FOR SOLID WASTE MANAGEMENT ASSESSMENT TO SPECIFIC PROPERTY OWNERS WITHIN
THE CITY OF MARSHALLTOWN

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARSHALLTOWN, IOWA:

Section 1. Section 1 of Ordinance #14571 of the Code of Ordinances of the City of Marshalltown, Iowa, is amended by striking the section and inserting in lieu thereof the following:

Each industrial and commercial assessment amount in the annual total amount, and each single family and multiple family assessment in the annual total amount per individual family unit for a fiscal year shall be set by Resolution of the City Council. These annual totals shall be billed on a monthly or bi-monthly basis, as determined by the City of Marshalltown, in a manner convenient to the City of Marshalltown. This manner of billing and collection may include inclusion of this amount on the water bill issued through the offices of the Marshalltown Board of Water Works Trustees.

Section 2. General Repealer.

All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

Section 3. Effective Date.

This Ordinance shall be in full force and effect after its passage and publication as by law provided.
