## **WAIVER OF SEPRATION REQUIREMENT**

### **2025-2026 Bow Hunt Season**

City requirements do not allow hunting within 200 feet of a home or building UNLESS the property owner or authorized manager of the property waives that separation requirement in writing and files with the City. The separation requirement applies to homes and buildings on the property being hunted as well as homes and buildings on adjoining properties.

This form shall be submitted to the City as evidence of a property owner's waiver of the 200-foot separation requirement. The waiver applies only to the property described in this waiver; only to the property owned by the person granting the waiver; and is subject to any and all conditions or limitations listed in this waiver.
